

- The Group Management, consisting of the Regional Managing Directors, the Business Unit Managers (currently only Air & Sea) and the CFO, who also acts as spokesperson for the Group Management, sets the overall strategy and manages operations and investments. Ultimate responsibility lies with the MMIH Board of Directors.
- The head office in St. Gallen provides support in the central functions of HR, QM and IT as well as in controlling and all other matters that are legally sound and binding.

#### The M&M Policy

- The Group Code of Conduct postulates a culture of compliance, environmental awareness and non-discrimination. We comply with all laws, including all sanctions and trade restrictions. Therefore, we do not transport goods that are banned worldwide or for which trade restrictions exist. For ethical reasons, we do not transport weapons, weapon parts, including sporting weapons and ammunition.
- ISO-certified business standards are enforced, while local management and staff guarantee customer and market proximity. Intra-group cooperation within the M&M network enables the use of synergy effects and is thus a valuable asset.



  - Insured limit per event & year: EUR 7,500,000
  - For customs duties/customs per claim & year:
    EUR 500,000
